TOUR BOOKING AGREEMENT

This Tour Booking Agreement between Food Wine Culture Tours, Inc., herein referred to as "FWCT", and _____ "herein referred to as the "Organization" is entered into as of this _____ day of _____, 200__ to set forth their respective duties, obligations, benefits and compensation in respect hereof. NOW THEREFORE, in consideration of the covenants, agreements, representations hereinafter set forth, and good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto do hereby agree as follows:

FWCT desires to sell and Organization desires to purchase reservations on the tour to _____ Date _____ more fully described in Attachment A, subject to the terms and conditions stated in Attachment B. This Agreement and Attachments constitute the full and complete understanding between the parties to this agreement and no oral terms and conditions are a part of this agreement. The person signing this document on behalf of the Organization does attest that he or she has been empowered by said Organization to enter into this agreement. If the Organization is not a legal entity, then the person signing is accepting personal responsibility for the agreement. This document is the sole agreement between the parties. Any changes to any of these documents must be prepared and agreed to in writing and attached as an amendment hereto.

Tour packages are normally planned, arranged and priced for the land portion of the trip. FWCT arranges airline itineraries and if such arrangements are a part of this agreement they will be described in an Attachment C. If FWCT does not arrange airline itineraries for the tour participants, the Organization is fully responsible for making those arrangements and is required to have done so and provided FWCT all participant itineraries by 60 days before departure. The Organization agrees to deliver participants to the starting point of the tour as described in Attachment A where FWCT's tour operator responsibilities begin.

A group-booking fee of \$ _____ is required within 10 business days from the date of this Agreement. Reservation, deposit and payment terms are stated in Appendix A.

FWCT is the principal tour operator and is responsible to the organization for all arrangements and for all tour services and accommodations offered in the tour. FWCT, its agents, servants and employees shall not be responsible for personal injuries or property damage, loss or delay, or change of itinerary incurred by the organization or any person or tour participant arising out of the act or negligence of any direct or supplemental air carrier, hotel or other persons rendering any of these services, or accommodations being offered in these tours. FWCT shall not be responsible for any injuries, death, damage, loss or delay in any means of transportation or by reasons of any event beyond the actual control of FWCT or of any agent or supplier or due to force majeure. The right is reserved by FWCT to decline or accept or to retain any person as a member of a tour, or to cancel a tour.

This Agreement shall be governed by, and construed in accordance with, the laws of the State of Maryland and deemed signed in Frederick County, Maryland on the date first indicated above. Any party hereto, without the written consent of the other party, shall not assign this Agreement. Neither this Agreement nor the relationship of the parties established hereby shall in any way constitute the parties to the Agreement as partners or co-venturer of the other party hereto. This Agreement is entered into solely for the purpose of setting forth the rights and obligations of the parties in respect hereof.
